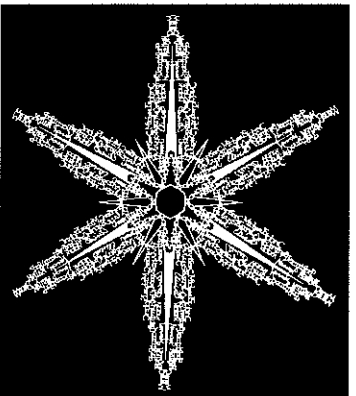

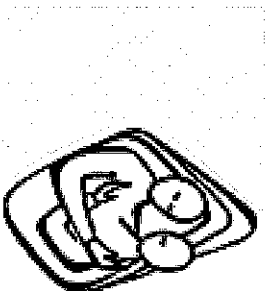

Our Meetings.....

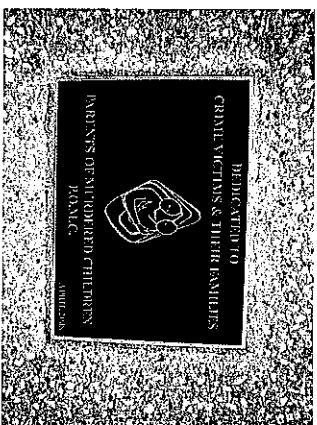
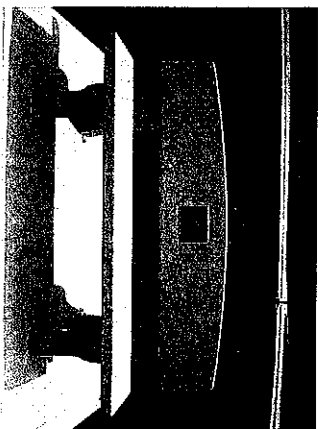
- provide a safe, welcoming place

- are where those who attend can truly understand what you are feeling and going through

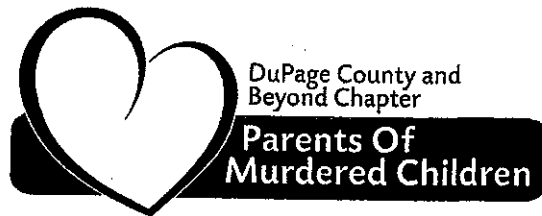
** You must be 18 years or older to attend.
